

The following is an explanation of the terminology used to complete the Disposition section of the Florida Tech Department of Security Crime Log:

- **Open Case:** The case is currently being investigated by Florida Tech Department of Security.
- **Unfounded:** The case is determined through a criminal investigation to be false or baseless. No offense occurred nor was attempted. This can only be determined by sworn Law Enforcement.
- **Closed. Referred to SCC:** The case is referred to the appropriate supervisory employee of the Student Counseling Center.
- **Closed. Referred to LOCAL POLICE DEPARTMENT:** The case is being investigated by the LOCAL POLICE DEPARTMENT.
- **Closed. Referred to Outside Agency:** The case is being investigated by a law enforcement agency other than the LOCAL POLICE DEPARTMENT. The specific agency will be identified in the disposition.
- **Closed. Referred to STUDENT CONDUCT:** The case has been forwarded to the STUDENT CONDUCT. This office is responsible for reviewing the case and for determining whether or not the student(s) involved will be charged with a violation(s) of the STUDENT CODE OF CONDUCT.
- **Closed. Referred to Title IX Coordinator:** The case has been forwarded to the Title IX Coordinator. The coordinator is responsible for reviewing the case and for determining whether or not a Title IX Investigation is warranted and/or whether any other action will be taken to resolve the case.
- **Closed. Off campus incident:** Closed. Case occurred off campus and is not within the jurisdiction of Florida Tech.
- **Closed. Subject Trespassed:** The subject(s) has been issued a Trespass notice which restricts the subject from entering or accessing any University property. A violation of a notice may result in that person's arrest for trespassing.
- **Closed. Police Arrest:** The subject(s) has been arrested by the appropriate local law enforcement agency.
- **Closed. No suspects or witnesses:** Case has no solvability.
- **Closed. No identifiable suspect:** A description and/or video surveillance of the subject is available but positive identification of the subject has not been made.
- **Closed. Reclassified to CRIME TYPE:** The original incident report classification has been changed to accurately reflect the appropriate classification, based on the results of the investigation.
- **Closed. No further action:** No further investigative action is required.
- **Closed. Received from Title IX Coordinator:** These are Clery crimes that were reported directly to the Title IX Coordinator. These cases are reported by the Title IX office and added to the crime log.
- **Closed. Forwarded to Department:** The case is referred to the appropriate department. They will review case and determine if disciplinary action will be initiated.
